Leasowe and Pilling cockle bed surveys and recommendations







Background

LEASOWE COCKLE BED

Resolution: Approve Leasowe Cockle Bed is open 1st October 2024 under paragraph 3 of Byelaw 3, <u>subject to additional survey</u>

Justification:

- 1. July surveys identified 799 tonnes of size on Leasowe, below the minimum size threshold of 800 tonnes needed for bird food resourcing
- 2. The proportion of size to undersize was low but much of the undersize was in the 20-25mm category that would likely grow to size; and
- 3. Leasowe cockle is known to grow fast therefore, may have sufficient biomass in excess of 800 tonnes of size by October.

Resolution: Approve Pilling Cockle Bed is open from 1st October 2024, under paragraph 15 of Byelaw 3, <u>subject to additional inspection</u>

Justification:

- 1. The greatest areas of biomass on the bed had a high proportion of undersize to size cockle.
- 2. The cockle would potentially grow on during the late summer months to reach a more favourable size:undersize composition




Figure 2: Density of size cockle per m2 at Leasowe September 2024




Figure 3: Density of undersize cockle per m2 at Leasowe September 2024




Figure 4: Frequency of size classes of cockle per m² at Leasowe September 2024




Figure 5: Weight of size and undersize cockle kg/m² at Leasowe September 2024



Leasowe recommendation

With 1370 tonnes of size cockle, the fishery can be opened with a 570 tonne TAC.

However, as the previous resolution stated the fishery be opened October 1st – this falls on a Tuesday and may be more pragmatic to allow the fishery to open on the Monday 30th September.

Recommendation:

Leasowe cockle fishery be opened as of September 30th 2024 under byelaw 3.




Pilling results

A section of Pilling was re-surveyed on September 13th

The location of the 18 points that were resurveyed is highlighted by the red line

These sites were chosen as they hold the bulk of the cockle biomass, are densely populated, but also had a highly mixed composition of size:undersize cockles in the July survey.

The recommendation at the August 13th TSB to allow more time for cockle to grow, was partly based on the concern that this area would be targeted – impacting juvenile stocks and raising compliance concerns





Pilling results

There was no significant change in the majority of the sample points – with the ratio of size to undersize cockles still low:



The size:undersize ratio of cockle is 35:65, which although has increased since July, is still relatively low.

Pilling recommendation

Due to the little change in growth of cockle on the Pilling cockle bed, there is still a significant number of undersize to size cockle on the main area of Pilling.

This raises concerns over the disturbance to juvenile stocks and removal of undersize cockle.

Previous fisheries have not been recommended opened under similar circumstances, and cockles have been provided the time to grow-on.

Recommendation:

Pilling cockle bed remains closed as of October 1st 2024 under byelaw 3.
